

STOCK HORSES

Division 120

Entries:

- **Entry Forms Accepted through Saturday, August 7, 2010 BY 5 PM.**
- Post Entries Accepted from Aug. 8-21, 2010 for an additional \$25.00 *per contestant*.
- Drug Fee: \$5.00 per horse
- **Show Starts Saturday, September 4, 2010, will not start before 11:00 AM (after Cutting Horse Show)**
- **Check in at 10 AM on Saturday, September 4, 2010.**

Rules & Information:

- Refer to Horse Show General Rules, Page 2, Local Rules, Page 56
- **Limit 10 Exhibitors per class or 50 Exhibitors per show.**
- Open to the World.
- Tie breaking in Reining and Working Ranch Horse: Prize money and purse from next placing will be combined and divided between contestants.
- Tie breaking in Jr. Horse, Sr. Horse, and Non-Pro Limited: Cow work determines the winner.
- Only NRCHA & NRHA approved headgear is permitted in stock horse events with the exception of the Working Ranch Horse classes, Judge may check bridles.
- NRCHA Rules apply to Jr. Horse, Sr. Horse and Non-Pro Limited Classes.
- NRHA Rules apply to Reining Class.

Awards:

- Sponsored Awards & Rosettes
- Cash Awards \$30-\$25-\$20-\$15-\$10
- **NEW** – Cash Awards will be based on number of contestants if less than five entries
- Purse (\$40 per person) Divided as follows: 30%-25%-20%-15%-10%

RANCH CUTTING

Entry Fee: \$80 + Drug Fee

Stock Charge: \$45 Purse: \$35 Drug Fee: \$5.00 per horse/per day

Class	Description
1	Ranch Cutting: Open to any age horse. Horse must be shown in smooth snaffle (no gimmick Snaffles allowed), hackamore (NRCHA approved). Rider must show two handed for show.

REINING

Entry Fee: \$40 + Drug Fee

Purse: \$40 Drug Fee: \$5.00 per horse/per day

Class	Description
2	Reining: Rider can show in Snaffle, Hackamore or Bridle. If showing in bridle, bit must be legal NRHA bit. Can show in split reins if showing in the bridle. This class consists of selected NRHA pattern.

JR. HORSE, SR. HORSE, NON-PRO LIMITED

Entry Fee: \$80 + Drug Fee

Stock Charge: \$45 Purse: \$35 Drug Fee: \$5.00 per horse/per day

Class	Description
3	Jr. Horse: Horse must be 5 years & under. Rider can show in Snaffle, Hackamore, or Two-Rein. NRCHA two rein rules apply. This class consists of the selected NRCHA pattern and cow work.
4	Sr. Horse: Rider must use full bridle with bit and one hand on the rein, NRCHA rules apply. This class consists of the selected NRCHA pattern and cow work.
5	Non-Pro Limited: Rider can show in Snaffle, Hackamore, Two-Rein or Bridle. NRCHA Two-Rein rules apply. Class is for riders who have not shown down the fence more than three times. This class consists of the selected NRCHA pattern and cow work is boxing only.

WORKING RANCH HORSE

Entry Fee: \$80 + Drug Fee

Stock Charge: \$45 Purse: \$35 Drug Fee: \$5.00 per horse/per day

Class	Description
6	Working Ranch Horse: Must be a currently working ranch horse. Cow work only no dry work. No gimmicks, i.e. tie down, mechanical hackamore, caveson, etc. Eligibility for class is determined by Horse Show Management. New cow at discretion of judge only.
