RULES AND INFORMATION:

- Limited to residents of Mariposa County and Eastern Madera County (east of Madera Canal).
- Judging will be closed.
- All entries in this division must have been sewn or constructed by the exhibitor and completed within one year of the opening day of 2015 fair. Articles which have been entered in any previous Mariposa County Fair are not eligible.
- Exhibits shall be cleaned and pressed. All knitted or crocheted items shall be blocked. Articles may have been worn or used but soiled items or items showing excessive wear will be disqualified.
- **Picture** is framed with screw eyes and wire, ready to hang. **Wall hanging** is unframed but has a usable hanger
- **DEFINITION OF ENTRY LEVELS:**
 - **Novice/Intermediate:** Exhibitors who have been exhibiting in this division for up to 5 years.
 - **Advanced/Professional:** Exhibitors who have been exhibiting in this division for 6 or more years and professionals.
